



### **CHALLENGES FACED BY M&S**

- Comply with new regulations while ensuring minimal time is added to the
  export process, operating as close to day one to day two delivery cycles as
  possible to maintain product range and shelf life.
- Products of Animal Origin (POAO), such as meat, dairy and eggs would require Export Health Certifications (EHCs) to move between the UK & EU, the creation of which requires data from across the supply chain.
- No available systems to support businesses that are facing these changes to operations.

We needed a solution that would not only allow us to comply with the new regulatory changes we were facing but that could integrate into our existing operations with minimal disruption.

## THE SOLUTION

M&S needed to find a solution that would help them adapt to the new SPS regulations, while also minimising the impact across their stores and supply chain. The supermarket giant exports short shelf-life, perishable products as well as long-life ambient and frozen items, moving them from its distribution centres to stores across the UK, NI and EU. The processes, therefore, had to be executed without consuming product shelf life and avoiding unnecessary costs. With the future still uncertain, regulatory requirements constantly evolving and negotiations ongoing, M&S decided they needed to act. The solution came in the form of a scalable and customisable digital platform that continually aligns with developing SPS regulations – P2D TS Traces.

P2D TS conducted a thorough analysis of the operating model and customised the solution to meet their exact needs. The platform was integrated and aligned with the M&S supply chain, their logistics partner, and Official Veterinarians (OVs).

### Benefits

- Reduces the data collection burden and admin for exporters by collating and presenting data from across the supply chain as evidence for sign-off by OVs - unique to the P2D TS platform.
- Full visibility of suppliers and carriers with itemised inventory, including all required documentation at the point of load.
- Automated creation of EHC schedules and certification in line with government regulations.
- Hypercare proactively manage issues before they arrive at the border, avoiding disruptions and facilitating the Just-In-Time operations.
- Standardises compliance processes across the supply chain, removing the need for multiple spreadsheets and SharePoint sites.
- Reduces internal development time, costs and complexities with a solution that aligns with evolving SPS EHC requirements.



## **RESULTS**


#### SIMPLIFYING THE COMPLEX

By utilising the P2D TS Traces solution, M&S were able to standardise compliance across their supply chain. The platform was aligned and integrated alongside M&S's logistics partner, providing the data and documentation required for the seamless movement of goods. The data collected is aggregated and used to create EHC schedules, simplifying the process of completing these documents and providing the OV with the evidence required to sign off on products. This results in less OV time spent on site and reduced costs for the business. By using the P2D TS Traces platform, M&S achieved day one to day two delivery cycles, resulting in only hours added to operations to comply with new regulations. Other businesses, however, lost days (day one - day five) on their delivery cycles of complex loads and composite products.

### P2D TS Traces supported M&S to achieve\*:

- 99.6% of exports to ROI arriving on time
- 100% of exports to NI arriving on time
- 100% of exports to France arrive on time
- 97% of stock received from suppliers has been capable of being exported, this is despite volume doubling and more complex products being launched

**Over 300 suppliers** in the M&S supply chain were onboarded onto the P2D TS platform.
